## INSTRUCTIONS FOR AUTHORS

Review article manuscripts should be submitted to the Editor-in-Chief without prior invitation at the following address. It is advisable that authors first submit an abstract to the Editor-in-Chief prior to submitting the full manuscript. The submitted abstract should outline the intended contents and coverage of their article. For full review articles, the manuscript, written in English, should not exceed 70 pages in length (ca. 30 printed pages) and for mini-reviews a maximum of 40 pages in length (ca. 15 printed pages). The manuscript should be typed in double-spacing throughout on A-4 or American quarto paper. Dot matrix print or any print that is difficult to read is unacceptable. Two copies of the manuscript must accompany the original (along with a passport size black and white photograph of the author and a computer disk) and should be sent to the Editor-in-Chief at his address. All pages should be numbered. Abbreviations should be defined the first time that they are used in the manuscript and a list of abbreviations used should be provided.

**Manuscript Organization:** The manuscript should be divided as: Title page, abstract and the main text. The text may be subdivided further according to the areas to be discussed. This should be followed by the Acknowledgement (if any) and Reference sections. The first page should contain the title, the author's names (initials and surname only), with an asterisk in front of the name of the principal author.

**Abstract:** The abstract should not exceed 250 words and it should condense the essential features of the review article, with the focus on the major advances in the field.

**Key Words:** Authors must supply up to eight key words along with their manuscript.

**Text:** The main text should begin on a separate page and it may be subdivided into separate sections. The review article should mention any previous important reviews in the field and contain a comprehensive discussion starting with the general background of the field. It should then go on to discuss the salient features of recent developments. The authors should avoid presenting material that has already been published in a previous review. The reference numbers should be given in square brackets in the text. Acknowledgements should be kept to a minimum.

**Tables:** The tables should be titled, and should be given separately with indications on the left hand margin to the text where the authors would like the tables to be inserted in the proofs. The tables should not contain vertical rules.

**Figures:** Figures should be referred to as "Fig. (1)", Fig. (2)" etc. in the text with the Figure numbers given in bold within round brackets. Each figure should be accompanied by a caption that should describe briefly the important features displayed in the Figure.

**Illustrations:** Colored illustrations and plates can be published from 35 mm color slides. Figures should be 70 mm or 180 mm wide wherever possible. Photographs of biological systems should be provided with a scale bar, where required. One color plate will be published free of charge in each article, provided color is deemed scientifically necessary by the Editor-in-Chief. Additional color figures will be charged to the author. The cost for the first additional published page of color figures is US \$550; the second additional page will be US \$400, and each subsequent page, US \$275.

**Structures:** The chemical structures must be prepared in ChemDraw (any version) and should be provided as separate file and submitted both on disk and printed formats. The structures should fit into a width of 8 cm (for structures to be inserted within single column widths) or a width of 18 cm (for structures or schemes to be inserted in double column widths).

**References:** References in the annotated reference list should be numbered consecutively in the order in which they are cited in the text. They should be assigned Arabic numerals, which should be given in brackets when they appear in the text, e.g., [10]. References should include the names of all authors, the full title, journal name, year, volume, and page numbers. Journal names should be abbreviated as indicated in *Index Medicus*. If the author is unaware of the appropriate abbreviation, the journal name should be given in full.

Mark references "of outstanding interest" with (\*\*) and label those "of special interest" (\*). Please place the asterisk to the left of the number. Annotations should be written for each reference that includes a (\*) or (\*\*) classification, providing a succinct description and evaluation of that information which makes these papers noteworthy. Please note that only references from the 1-year period being reviewed should be annotated and bulleted. There should be no more than five references marked outstanding interest (\*\*). The same applies to special interest (\*).

Please be aware that unpublished data, abstracts, and personal communications must not be given in the references section but they may be mentioned in the text and details provided as footnotes.

**Manuscript Submission:** Two copies of the manuscript must accompany the original along with the soft copy of the manuscript on a computer floppy disk(s) in MS Word file format (or created in other well known word processing software) should be submitted. For expedient and speedy reviewing of author's manuscripts, authors are strongly advised to include the PDF file of their manuscript on a floppy or zip disk, into the mailing material. At the same time the package is mailed, please also send by e-mail a copy of the PDF file of the manuscript to the journal Editor-in-Chief

**Online Abstract and Manuscript Submission:** To facilitate speedy and cost effective submission of abstracts and manuscripts, an online submission service via the Internet is available at [www.bentham-ftp.org](http://www.bentham-ftp.org) Please visit this website for submissions and further details.

Once your abstract has been accepted by the journal Editor, you may submit your full manuscript online via our online submission service. You may although still submit your abstracts and manuscripts by conventional surface mail.

**Page Charges:** No page charges will be levied to authors.

**Proofs:** Authors are sent page proofs. To avoid delays in publication, proofs should be checked immediately for typographical errors and returned within 48 hours. Major changes are not acceptable at the proof stage.

**Copyright:** It is a condition of publication that manuscripts submitted to this journal have not been published and will not be simultaneously submitted or published elsewhere. By submitting a manuscript the authors agree that the copyright of their article is transferred to the publishers if and when the article is accepted for publication.

**Free Subscription:** A free online subscription to the current volume of *Current Genomics* will be provided to each first named author. First named authors may also order a personal printed subscription of the journal at 50% off the normal subscription rate.

**Reviewing and Promptness of Publication:** All papers submitted for publication will be immediately subjected to editorial scrutiny, usually in consultation with members of the Editorial Board. Every effort will be made to assess the papers quickly and the decision conveyed to the authors normally within two weeks of the receipt of the paper. The papers will be typeset and the proofs dispatched to the authors normally within 4 weeks of their acceptance.
